Before you attend Trade School you must notify your employer. Upon layoff you must sign the Out of Work List stating you are "Attending Trade School". When you are finished school, you must report to the union hall again. A reminder, you have 90 days to write your C of Q. If you aren't successful prepare to visit the Council.

NEWS FROM THE BENEFIT OFFICE

- SUB cheques are printed on the 1st and 3rd Tuesday of each month.
- Clothing Allowance cheques are printed on the 1st and 3rd Tuesday of each month
- Vacation Payout for November 1 to April 30, will be Monday June 1, 2020. Any cheques not
 picked up by the end of the day Friday June 5, 2020 will be mailed out on Monday June 8, 2020. (If you wish
 to have your cheque picked up please call ahead for the rules or have your Steward create a signing sheet by
 Friday May, 29 2020).
- **Semi-private coverage** is paid from the **Benefit Office** not Green Shield. You must notify the hospital to bill Local 773 **NOT GREEN SHIELD** upon check-in. Also, be aware that coverage is for a maximum of 30 days per calendar year. Any stay over the 30 days is at your expense.

We have received numerous complaints that mobile devices are being used at work, during working hours. Facebook post, Instagram and Snap Chatting should happen on your own time. It not only makes us inefficient, by focusing our attention on things other than our assigned tasks, it creates an unnecessary liability that could relate to a workplace injury or fatality.

PLEASE BE REMINDED THAT ACCORDING TO THE CONSTITUTION OF THE IBEW YOUR OBLIGATIONS ARE:

Article 21

Sec.1. No member is entitled to notice of monthly or quarterly dues of his L.U., nor of arrearages, but must take notice when payments are due. Sec.2. When a member's working card has expired, he at once, stands suspended from all L.U. benefits, No member will be dispatched without a current dues receipt.Sec.3. Any member indebted to his L.U. for three months' dues or having any past due indebtedness to the IBEW for dues or assessments, shall stand suspended, and the L.U. may refuse to accept dues from any member who is indebted to it. Such member cannot be reinstated until all indebtedness has been paid, unless waived by the L.U. However, dues cannot be waived. Sec.4. any member indebted to his L.U. for six (6) months' full dues shall be dropped from membership by the F.S. and cannot become a member in good standing again in the I.B.E.W. except by joining as a new member.

AS OF JANUARY 2020, DUES are \$62.00 PER MONTH

If you get 90 days behind in your International dues the International office charges a \$30 late fee

Accepting Visa/MasterCard for monthly dues for a charge of \$1.00 extra

Direct Withdrawal for dues is available. Bring a void cheque and fill out the form at the hall.
